Call for Abstracts

Abstract Submission

In line with the conference vision, scientists, academicians, students, research scholars, and industry professionals from the pharmacy and medical fields are invited to participate and present their research.

Abstract Guidelines

Participants wishing to present their work must submit a structured abstract not exceeding 250 words. The abstract should include the Title, Author(s), Affiliation, Email ID, Contact Number, Background, Materials and Methods, Results, Conclusion, and Keywords. Abstract submission is mandatory for all participants opting for oral presentations.

Oral Presentation

Participants are required to prepare a PowerPoint presentation consisting of 12-15 well-structured slides. The total presentation time will be 15 minutes, with 10 minutes allocated for the oral presentation followed by 5 minutes for discussion and questions.

Evaluation & Ethics

All presentations will be evaluated based on clarity of content, scientific accuracy, and originality of the work. Presenters are expected to prepare clear, well-organized, and easily readable slides, avoiding overcrowding of text and ensuring effective visual communication. In addition, all submissions and presentations must strictly adhere to ethical standards and responsible presentation practices, including proper citation of sources and avoidance of plagiarism.

Participants are encouraged to present their research through an oral presentation in the following areas:

- Harnessing AI for Transforming Drug Discovery, Development, and Quality Assurance in the Pharmaceutical Industry
- Pharmaceutics
- Pharmacology and Clinical Research
- Pharmaceutical Chemistry & Analysis
